## **Actions Required**

- 1 If there are problems with the site preparation or the site services, an engineer's visit will be charged at the normal rate.
- Provide a cupboard or space next to the unit for all the electrics and pipe work. Read sections 3 2 Sections 1, 3, 4 & 4 for the minimum width required.
- 3 Ask your contractor to source the necessary site termination discussed in section 2. Section 2

## 1. Choosing a Location

## 1.1. Requirements

#### Accessibility

There must be easy access to the room, and to the final location of the unit.

A minimum clearance of 65cm is required through doorways (a standard household doorway provides this).

#### **Washer Disinfector Housing**

#### **Built-under**

It can be installed under a continuous worktop or sink drainer.

The recess must be at least 620mm wide, 600mm deep and 840mm high\*.

Noise level built-under: <70dB (A)

#### Freestanding, slot-in, or at the end of a row

It can be installed next to other machines or furniture, or in a suitable location.

The location must be at least 620mm wide and 600mm deep.

Noise level built-under: <70dB (A)

\* If the height under the worktop is less than 840mm, Eschmann can, at installation, remove the top cover, thereby allowing the unit to fit into a minimum recess height of 835mm. Please contact Eschmann prior to installation as this will incur further charge.

#### **Usable Empty Space**

Provide a space or cupboard next to the unit at least 400mm wide for all the electrics and pipework.


## 1.2. Considerations

- Furniture and fittings installed near the unit must be of a commercial standard, able to withstand the effects of steam and condensed water.
- Do not site the unit under a fire or smoke alarm as the steam released from the cabinet after each cycle can trigger the alarm. A minimum of 3 metres from the unit is a safe distance for any smoke or fire alarm.
- Heat dissipation through heat radiation: 0.35kWh/h.
- · Load heat dissipation on removal: 0.40kWh/h.
- The unit must sit level to operate correctly.
- To fit the Washer Disinfector into a cupboard, the installer will need to make cuts into the cupboard partition (refer to Fig 1). You will also require a neat hole in the worktop if you are fitting the Autolog or Printer above the worktop.
- The Washer Disinfector requires a separate drainage connection and is to be made from commercial grade waste pipe due to the temperatures exhausted down the waste.. This can be either:


An open drainage system: easy to fit stand-pipe, but may be susceptible to spillage in the case of a blocked drain.

A closed drainage system: requires a standard 22mm pipe run, but will prevent spillage in the case of a blocked drain.

- The unit requires two cold water supplies. A third RO/DI water supply is optional.
- It is important that you use only Eschmann approved and validated consumables/ test devices with this washer disinfector. Other consumables could be too aggressive resulting in damage to the washer disinfector or instruments and will not be validated to clean instruments effectively.

Mains electrical plug (connect to WD) to be supplied by contractor

Non-return valve to mains water supply

## 2.1. Flectrical Notes

- The unit MUST be earthed via a correctly installed earthing system.
- We recommend that the supply incorporates a residual current device (normally located near the distribution board) with a trip current of 30mA.
- Hard-wiring the appliance to a wall socket is NOT acceptable as routine maintenance will be affected.
- Install a double, switched socket wired to the domestic supply. We recommend that it is a waterproof socket, although a "normal" socket may be used at the contractor's discretion.

## 2.2. Plumbing Notes

The mains water supply connection point must be easily accessible. Check that the minimum mains water pressure is not affected by other equipment using the same supply. The water pressure must never fall below the minimum 1.0 bar, 100 kPa, even under flow.

All pipework for (optional) RO/DI water must be made from plastic or stainless steel.

The unit requires one of the following separate drainage connections:

Open drainage system (standard option): fit a standard 40mm diameter waste pipe and waste trap, 300mm down from the worktop. This waste pipe should empty into the foul water sewer.

Closed drainage system: fit a standard 22mm copper pipe run, 300mm down from the worktop for any connector/adaptor fitted to the end of the pipe. This pipe should empty into the foul water sewer. At the Washer Disinfector end, point the pipe down and provide 30mm of pipe for Eschmann to connect to.

**Connection to a sink trap** is possible but this MUST be to the drain side, not the sink side. Call for advice.

The Eschmann Service Engineer will connect the Washer Disinfector's outlet hose to the drainage connection.

- A longer outlet hose can be supplied at extra cost where required (part number MS1545805, 2.25m). Do not use a hose longer than 4m.
- The drainage system beyond the connection point must be capable of draining up to 16 litres/minute.
- The waste water that drains could be up to 10 litres at 95°C for periods of up to 2 minutes every 45 minutes.
- The unit is fitted internally with a non-return valve which prevents dirty water from flowing back into the Washer Disinfector via the drain hose.
- The site's waste pipe must be of commercial grade due to temperatures of up to 95°C. (Recommended material, Vulcathene).

Do not install the Washer Disinfector in an area where a danger of explosion or freezing conditions may be present.


This equipment is not designed for maritime use or for use in mobile installations such as caravans, aircraft etc. However, it may be suitable for such usage subject to a risk assessment of the installation being carried out by a suitably qualified engineer.

Ratification: Water Regulations Advice Scheme (WRAS) Fluid Category 5 - Type AB Air Gap and Double Check Valve (backflow prevention devices). WRAS approval: contact Eschmann for up-to-date certificate.



## 5. Optional Equipment

## 5.1. Autolog (8701027)

Eschmann can supply and fit the RS232 Autolog during installation.

The Autolog requires a standard domestic mains socket for power. It connects to the Washer Disinfector via an RS232 cable connected to a socket at the rear of the Washer Disinfector.



If the Autolog is to be situated in the cupboard with other services, then the connecting cables can go through the partition cut-out. A mains socket will be required under the worktop.


If the Autolog is to be situated on the worktop above the Washer Disinfector, then a hole for the connecting cables may be required through the worktop and any cupboard panels. Position a 12.7mm (1/2") diameter hole close to the back wall. A mains socket will be required above the worktop.

## 5.2. RS232 Printer (8721367)

Eschmann can supply and fit this optional RS232 printer during installation.

The Printer requires a standard domestic mains socket for power. It connects to the Washer Disinfector via an RS232 cable connected to a socket at the rear of the Washer Disinfector.

If the printer is to be situated in the cupboard with other services then the connecting cables can go through the partition cut-out. A mains socket will be required under the worktop.



## 5.3. Eschmann RO Water System

Eschmann can supply an RO System with UV (8785154UVCSHW).

In addition, we can supply a WD Adapation Kit (8785513), which has a larger tank to increase water capacity.

# 5.4. RO/DI Water Supply (Third party system)

## RO/DI Requirement for Thermal Disinfection/ Final Rinse (Not the entire cycle)

The Site Preparation Installation parts detailed in Sections 3 and 4. Include the Plastic Speedfit tap required for this installation.

Note: Please discuss the pipework and positioning requirements for the RO plant with your RO supplier.

The RO/DI module must be specified and ordered independently.

The Reverse Osmosis or De-Ionised (RO/DI) water supply is an optional feature. It supplies filtered water for rinsing purposes to the Washer Disinfector.

# Your RO/DI module must have the following specification:

- 1. Delivery rate: 10 litres per minute (5 litres per minute **minimum**)
- 2. Volume of water required: 12 litres per hour **minimum**
- 3. A constant delivery pressure of 1.5 barg **minimum** at all times during filling (maximum 10 barg)
- 4. A pressurised system
- 5. A suitable backflow prevention device for the Category 5 fluid processed by this WD

We don't know the dimensions of your RO/DI module, but it will probably need to be sited outside of the cupboard/space and in the close vicinity. Generally the independent RO/DI water system needs to have a pumped supply to the Washer Disinfector to provide a constant pressure of 1.5 barg.

The requirements for the unit are:

- 1. The RO/DI module requires a separate mains cold water supply waste connection, and mains electricity.
- 2. Provide a water supply pipe from the RO/DI module to the Washer Disinfector site. This pipework must NOT be copper. It could be plastic or stainless steel, to terminate in a 3/4" BSPP connection to connect to the RO port on the WD unit. Confirm with your RO supplier. House the connection in an area next to the Washer Disinfector (refer to section 3). DO NOT place pipework or electrical wiring behind the Washer Disinfector.
- 3. The Site Preparation Installation parts detailed in Sections 3 and 4 contain a plastic washing machine tap for the final connection to the Washer Disinfector.
- 4. The RO/DI module chosen is to incorporate a Back-Flow Prevention device Type A Air Gap for Cat 5 compliance: suggest Type AA, AB, or AD Air Gap, in line with BS EN1717.

When installing the Washer Disinfector, the Eschmann Service Engineer will reprogram the Washer Disinfector to accept the RO/DI module option.

## 6.1. Rinsing Aid

# RINSING AID CONTAINER TO BE INSTALLED BY ESCHMANN

The rinsing aid container is a standard feature of the Washer Disinfector and is used to dose rinse aid automatically into the unit. It is supplied with the Washer Disinfector and will be installed by the Eschmann Service Engineer.

The container requires no services.

It is one of two containers that space must be provided for on site (Refer to section 3). Good access is required to the container to enable easy replacement. Connect the suction pipe from the washer disinfector that is marked RED.

The rinsing aid container is 245x145x225mm (LxWxH), 5 litre capacity.

## 6.2. Detergent

# DETERGENT CONTAINER TO BE INSTALLED BY ESCHMANN

The detergent container is a standard feature of the Washer Disinfector and is used to dose detergent automatically into the unit. It is supplied with the Washer Disinfector and will be installed by the Eschmann Service Engineer.

The container requires no services.

It is one of two containers that space must be provided for on site (Refer to section 3). Good access is required to the container to enable easy replacement. Connect the suction pipe from the washer disinfector that is marked BLUE.

The detergent container is 245x145x225mm (LxWxH), 5 litre capacity.
